- **9. Pro Bono Financial Support**. The Committee discussed the financial support the Section provides to the pro bono Bankruptcy Clinic and the Bankruptcy Judges' Reception.
- **10. Meeting Scheduling for 2023 & OSB Requirements.** The Committee reviewed and discussed current OSB guidance regarding meetings, public notice requirements, and remote attendance challenges and opportunities.
- 11. Other Business: Request re UCC new Article 12. The Committee considered the Legislative Committee's proposal to add a new Article 12 to the UCC and its request that our Section sponsor the bill. Ms. Hayman moved to seek approval from the Bar to allow our Section to sponsor the bill. The motion passed unanimously.
- 12. Adjournment. There being no further business, the Chair adjourned the meeting at 1:50 PM.
