Nada introduced herself as judge Renn new law clerk.

Series of retirements in Oregon the past few months. In a hiring phase right now. Some Seattle practitioners are helping out

Jordan: Ch 13 motion to dismiss procedures filed by trustee – changes will happen October 1st. 28 day notice. No response means case can be dismissed. McKittrick initiated the change. If you want to be heard you need to respond. Does it apply to motions filed by creditors? Pearson isn't sure – we don't get very many by creditors. The court will take a look at it. The universal response form will be revised. Mike – pro bono program. Wants to know how many applications for pro bono are being accepted/being successfully assigned to attorneys. Also – there are situations where there are cash poor/asset rich debtors that are asking for and getting assistance. Should be focused on cash poor/asset poor debtors.

Kirsten will get stats for the Salishan meeting as there will be a session on it.

Pearson says it is for discrete tasks. She tries not to appoint it in cases where there are assets. Sees it more as someone who needs an hour or two to get on the right track, rather than a case where it will take a lot of time and involvement all the way through

Renn: it was a spinoff of district court and the discrete task purpose is the initial purpose. Also helpful at settlement conferences. Should be a limited basis-isn't designed for the situation where they need counsel throughout. If it takes more than an hour or so, there may be a way to structure it to include attorney fees in the plan. Judge renn is willing to work with that to create something that will work. He notes that often he signs an order and we still can't find a lawyer.
